Congress slams Harsh Vardhan over death of children due to encephalitis in Bihar

New Delhi, June 18

The Congress hit out at Union Health Minister Harsh Vardhan on Tuesday over the Acute Encephalitis Syndrome (AES) outbreak in Bihar, which has claimed the lives of over 100 children, saying there is "no work, all talk".

The death toll due to the outbreak has climbed to 105 in Bihar's Muzaffarpur district with the State-run Sri Krishna Medical College and Hospital (SKMCH) and the privately-owned Kejriwal hospital reporting one casualty each in the intervening night
