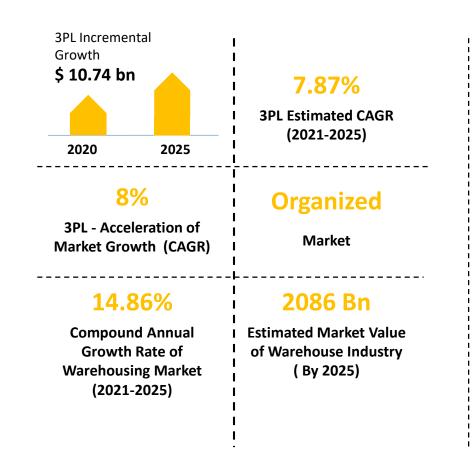

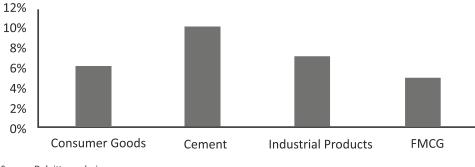




TCI TCI Supply Chain Division: Industry nature and trends



Typical Logistics and Warehouse Cost (as a % of Sales)



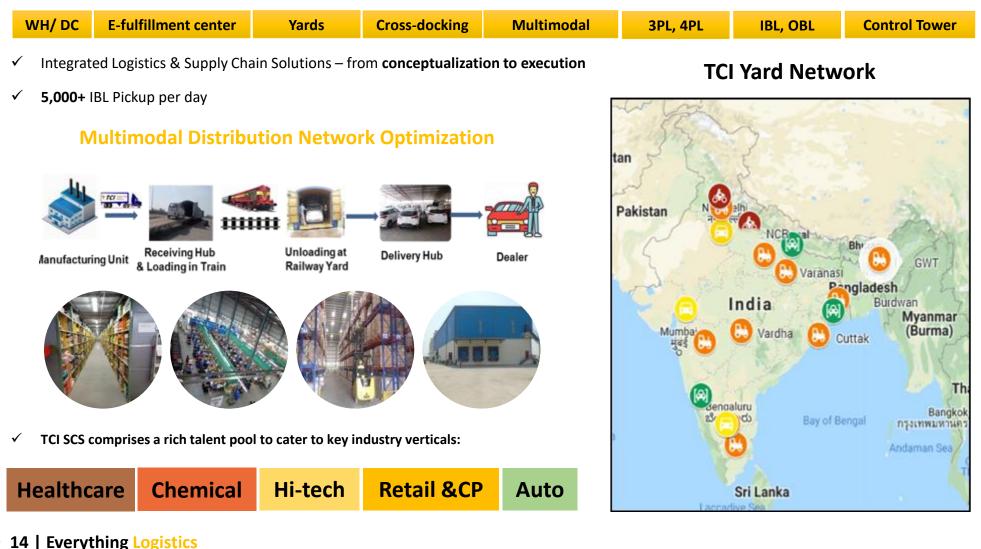
